Fire.	L1 x C4	<p><i>A trained first aider is always on duty at the museum.</i></p> <p>Standard Evacuation Procedure. Ensure teachers are informed of Fire Evacuation procedures. Fire alarm is linked to the Fire brigade.</p>
Damage to and from glass cases	L2 x C3	Assistant and school adult supervision. Glass is toughened or covered with safety film.
Stairs, trips	L2 x C2	Children to be warned in briefing not to run in museum.
Children going outside, wandering off, abduction, assault	L1 x C4	Appropriate briefing by staff on arrival and ensure compliance with instructions. No children should leave the building unless supervised by school and museum staff.
Danger from other museum users	L1 x C4	The museum is open to the public during school sessions with museum assistants on duty at the reception desk, and patrolling through the museum; with CCTV access on the front desk (recorded at the Council CCTV Control Room). Museum staff are CRB-checked.
Open doorways to private areas, giving access to unquantified dangers	L1 x C3	Routine locking of private area doors
Children handling items eg irons, shell	L1 x C4	Warnings from demonstrator on specific hazards. Children may handle a small number of items in the session, possibly in the Victorian kitchen and possibly including military/regimental items (depending on the session). The children will be under close supervision by museum staff and school adults (who will be briefed on their supervisory duties) at all times whilst handling artefacts.
Heat exhaustion	L1 x C3	Education Room is air conditioned. Water is available.
General		<p>Lights fitted in park; CCTV coverage</p> <p>All museum staff are CRB Checked.</p> <p>The Museum recommends that teachers visit in advance to identify hazards specific to their charges eg phobias, special needs, and that these are notified to the museum staff before the visit takes place.</p>
